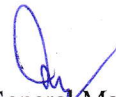

1. Last date for receipt of tender is 18/09/25 upto 5.00 P.M. Which will be opened and negotiations will be held on 19/09/25 at 10.00 A.M. with the lowest quote only, if required.
2. Material offered should be strictly as per our specifications and in the Tender Form issued by the Mills only.
3. Minimum delivery period must be mentioned.
4. The rates should be FOR Sugar Mills. No escalation whatsoever it may be not entertained.
5. The successful bidder will have to supply the entire ordered material with in ----days after issuing the order under reference.
6. GST and other taxes if any as applicable at the time of supply will be paid extra on submission of requisite invoice/documents thereof along with proof of GST/other duties.
7. Delivery period will be finalized by the committee during the negotiation, in case the supply of ordered material gets delayed, a penalty will be imposed/charged @ 2% per week (Max 10%) or as decided by the purchase committee at the time of negotiation.
8. Tender should be submitted as per terms & conditions of the DNIT. Any deviation will result in rejection of tender.
9. Payment terms will be decided by the purchase committee during negotiations.
10. Negotiation, if required, will be held with the lowest tenderer only.
11. The supplier shall be liable to replace defective /rejected material, if any, at its own cost.
12. Inspection of material will be mode at Mill Site or as decided by the purchase committee.
13. The contract shall be subject to the provision of section 56 days of the Indian Contract Act, 1872.
14. The contract shall be valid for 30 days from date of opening of Tenders.
15. Any dispute shall be subject to the Nawanshahr, Distt, S.B.S. Nagar (Punjab) jurisdiction only.
16. In case, your rates are found less in any other Co-op, Sugar Mills in Punjab, the same will applicable to our Mills also.
17. The committee reserves the right to accept or reject any or all the tenders without assigning any reason, thereof committee reserves the right to after any terms and conditions of the tender, if required.
