4. One Percent Penalty per week of delay subject to maximum of 5% will be imposed or as decided by the purchase committee at time of negotiation.
5. 100% payment will be made after quality inspection of material or as decided by the purchase committee at the time of negotiation.
6. Authorisation certificate of dealership should be enclosed with tender form.
7. Rates should be FOR Mills, P&F, if applicable should be mentioned separately in percentage.
8. GST- extra if applicable as per Govt. rule.
9. The envelope of tender should be subscribed as Tender for **Other mill material (Welding Material)**
