TERMS AND CONDITIONS

MILLS RESPONSIBILITIES:

1. Supply of Chemicals & other material required to run ETP.
2. Repair of Machinery, Electrical fitting & Civil work as required.
3. Free accommodation for Supervisor only.

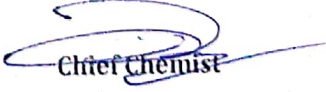
CONTRACTOR'S RESPONSIBILITIES:

1. Online continuous monitoring system must be functional during crushing season and one month after close of season to send data online to PPCB & CPCB. If there is any problem raised by PPCB or CPCB regarding online continuous monitoring system you have to rectify immediately without any delay.
2. To start seeding and developing of biological culture round 'O' clock one month prior to start of crushing season, and to supervise ETP operation till one month from end of crushing season 2026-27
3. Your Supervisor will visit atleast once a week or as and when required by the Mills to supervise operation of ETP and make his presence in log book.
4. To ensure that treated pollutants Water conforms to the prescribed norms as per PPCB.
5. To maintain regular inlet & outlet flow of untreated & treated water.
6. Supervisor will ensure that Log Book for ETP is properly maintained.
7. You will submit the Environmental Audit Report as per requirement of PPCB.
8. Self monitoring (Monthly) will be done both of ETP as per requirement of PPCB.

PAYMENT & GENERAL TERMS & CONDITIONS:

1. 70% of monthly payment will be paid against running bill & 30% to be released after close of season subject to following:
 - a. Sample of Water collected by the PPCB Authorities conform to prescribed parameters.
 - b. In case Board Authorities do not collect the sample during crushing operation full payment will be released to contractor after the submission of Environmental Audit Report as per requirement of PPCB.
2. Payment for monthly operation shall be made on pro-rate basis if the working is less than 30 days for particular month.
3. Contract shall be as per rules & regulations.
4. TDS shall be applicable as per rules & regulations.
5. GST- extra if applicable as per Govt. rule.
6. Contractor should have experience of supervision of ETP operation in sugar mill/other industries.
7. Last date for receipt of tender is 18/08/26 upto 5.00 PM which will be opened and negotiation if required will be held with the lowest tenderer only 19/08/26 at 10.00 AM.
8. The envelope of tender should be subscribed as Tender for **Contract for operation of ETP**
9. Jurisdiction: Any dispute there items shall be subject to jurisdiction of Nawanshahr.
10. The undersigned reserves the right to reject/ accept any or all tenders without assigning.
