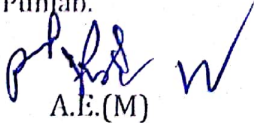

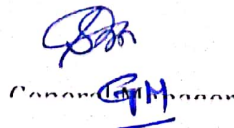

1. Last date for receipt of tender is 18/03/26 upto 5.00 P.M. Which will be opened and negotiations will be held on 19/03/26 at 10.00 AM with the lowest quote only, if required.
2. Quantity of work can increase OR decrease at the time of execution of job.
3. Free accommodation & Water for you and your staff will be arranged by the Mills in Mills Colony.
4. All tools and tackles will be arranged by the Mill.
5. Workshop facilities will be provided by the mills.
6. The TDS will be deducted as per rules
7. GST extra if applicable as per Govt. rule.
8. The progress of the work of the Contractor will be reviewed on weekly intervals and in case the mill management feels/finds, that the work is not being carried out as per schedule by the Contractor, he will have to employ more manpower to complete the job within stipulated time. In case of failure to comply with order of mills management, the mills shall get the job done through alternator sources at the entire cost, risk and responsibility of the Contractor.
9. The Contractor shall have to abide by all the rules and regulations of the Mills.
10. The Contractor will be responsible for all statutory liabilities like provident fund, workmen compensation in case of any injury and insurance etc. to his workers. The Mills shall not be in any way liable/responsible for the work force to be employed by the contractor.
11. All consumable items for Dismantling, fabrication & erection such as tubes, pipes, plates, welding electrodes, gases etc. will be provided by the Mills.
12. The consumable items to be issued to the contractor under the signature of concerned Engineer/Mfg. Chemist, duly counter signed by the Chief Engineer/Chief Chemist.
13. The Contractor will be responsible for any damage to Manpower/Machine during working, if it happens so.
14. 90% payment will be making work after completion of jobs balance 10% after 1st general cleaning or as decided at the time of negotiation.
15. The undersigned reserves the right to reject/accept any or all tenders without assigning reasons.
16. Jurisdiction:- Any dispute related to this order shall be subject to the jurisdiction of Nawanshahr (S.B.S. Nagar) Punjab.
